- Failure to comply with municipal, provincial, or federal fire codes.

We accept returns within 30 days of delivery on all products – including opened or assembled un its. Products must be in reasonable condition and include original components.

To initiate a return, email info@bonfiresupply.ca with proof of purchase and photos (if applica ble). Customers are responsible for return shipping unless the product is defective or incorrec tly shipped.

WARRANTY:

All products include a 1-year limited warranty covering manufacturer defects. This does not cov er:

- Weather-related damage (rust, corrosion)

- Damage due to misuse, improper installation, or lack of maintenance

#### **BBQ Products**

#### **Fire Pits**

FIRE PITS - SAFETY, LIABILITY & BYLAW NOTICE

- Wood-burning fire pits are only allowed for cooking in Toronto (e.g., hot dogs, marshmallows must be present).

- Fires must be small, supervised, and on non-combustible surfaces.

- Keep extinguishing tools nearby at all times.

Bonfire Supply is not responsible for bylaw violations, misuse, or failure to comply with local fire codes. Use of fire pits constitutes acknowledgment of responsibility.

#### **Patio Heaters**

PATIO HEATERS – WARRANTY & LIABILITY
